

Cookie Policy

What are cookies. Cookies are small text files that the sites visited by users send to their terminals, where they are stored

and then sent back to the same sites on subsequent visits.

"Technical cookies" (or browsing cookies) which contribute to the functioning of the Site, for example allowing

you to navigate between pages or to access the reserved area of the Site; the legal basis of the processing for

the use of these cookies is the interest of Finanza Dati Analisi S.r.l. in providing its customers efficient and well-

functioning services; these cookies are stored from the date of first access to the site until they are disabled.

• "Performance cookies" which allow the acquisition of statistical information in aggregate and anonymous form,

in relation to browsing habits; the legal basis of the processing for the use of these cookies is the consent of the

data subject; these cookies are stored from the date they are activated on the site until they are disabled. Users

can accept or disable these cookies – as they wish – using the table below or the cookie management tool and

related widget.

• "Functional cookies" which allow you to activate specific features of the Site and store your preferences (such as

language), in order to improve your browsing experience; the legal basis of the processing for the use of these

cookies is the consent of the data subject; these cookies are stored from the date on which they are activated

on the site until they are disabled. Users can accept or disable these cookies – as they wish – using the table

below or the cookie management tool and related widget.
