Pursuant to current regulations and the provisions of Article 13 of Regulation EU 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter, the "Regulation"), we inform you that the Data Controller of the data provided by you is FIDA Finanza Dati Analisi s.r.l. Browsing data

The computer systems and computer programs used to operate this site collect certain personal data whose transmission is implicit in the use of Internet communication protocols (e.g. IP addresses or domain names of the computers used to connect to the site, parameters relating to the operating system and IT environment of users, etc.).

Although this information is not collected to be associated with identified data subjects, given its nature it could allow the identification of users through processing and association with data held by third parties.

These data may only be used to elaborate statistical information not associated with any user identification data regarding use of the site and to check the proper functioning of the site, and will be deleted immediately after processing.

Your data may be used to ascertain liability in case of hypothetical computer crimes against the Site.

Data voluntarily provided by users

Users are not required to provide any personal data in order to consult the site.

However, any contact with Fida or the optional, express and spontaneous sending of messages, by email or traditional mail, to the Fida addresses shown on the site involve the subsequent acquisition of the address, including email, of the sender or the relevant phone number, necessary to respond to requests, as well as any other personal data included in the related communications.

These data may be processed for one or more of the following purposes:

- to follow up on the user's request/provide the service;
- to evaluate and improve the services and develop new ones;
- subject to express user consent, to send informative and commercial communications, including promotional messages (such as our newsletter) or service offers from the owner;
- to fulfil legal obligations and/or comply with orders from public authorities, including judicial authorities;
- to elaborate and disseminate statistical analyses and graphic representations, in aggregate and anonymous form only,



and may only be disclosed to third parties if necessary to achieve such purposes.

Data processing for these purposes does not require user consent (with the exception of sending informative and commercial communications or service offers, which requires express user consent), since processing in such cases is necessary for the performance of a contract to which you are party, in order to take steps at your request prior to entering into a contract, for compliance with a legal obligation, or for the purposes of legitimate interests pursued by the data controller or by a third party (Article 6, Paragraph 1, Points (b), (c) and (f), of the Regulation).

The processing will be carried out using manual and/or IT and telematic tools with organisation and processing logic strictly related to the purposes and, in any case, such as to guarantee the integrity and confidentiality of the data processed.

These data are retained for the time strictly necessary to provide the user with the requested service and are deleted immediately afterwards, without prejudice to additional obligations established by law.

Your data will not be disclosed.

For the performance of its business and the purposes listed above, Fida may rely on services provided by third parties operating on its behalf and following its instructions, who are appointed processors. These subjects provide processing or instrumental services to Fida (e.g. IT services for the operation of the site).
